Student Housing & Residential Life Bayou Oaks Townhouse Guidelines

In accordance with the University Of Houston Student Code Of Conduct, Student Housing & Residential Life (SHRL) and Center for Fraternity & Sorority Life (CFSL) will enforce all standards noted. Below you will find specific details related to Townhouses at Bayou Oaks, and the prohibited conduct as noted in the Student Code of Conduct. The Student Code of Conduct in its entirety can be found

Appearance of Townhouse Porches

- Porches must be kept in livable conditions. (3.34C)
- Trash on porches should be thrown away regularly. (3.34F)
- Porches should not be used as a storage area. (3.34C)
- If a porch is being used a temporary work space for organization projects, the materials should be stored properly, safely, and away from eye-sight at the end of each work session. (3.34C)

Use and Storage of Grills

- Grills can be no larger than 5 feet in length and 4 feet in width. (3.34C)
- Organizations are able to store 1 grill each. (3.34C)
- Grills on trailers are not allowed to be used or stored at Bayou Oaks. A parking space can be used for a trailer if it has a UH Economy parking permit, Bayou Oaks parking permit, and the Bayou Oaks parking permit holder is not responsible for another Bayou Oaks parking space. (3.34G)
- Charcoal and other remnants from grill-use must be disposed of properly and should not be left on the ground. (3.34F)
- Sharp utensils such as skewers, knives, pronged forks must be stored properly in the townhouse when not in use. These utensils should not be left unattended on a grill. (3.34C)

Alcohol and Smoking

- Alcohol, Alcohol bottles, and vessels used to hold alcohol are not to be consumed, stored, or held on townhouse porches, in the area surrounding townhouses, or in common spaces of Bayou Oaks. (3.34A)
- Tobacco products are not to be used within 25 feet of a Bayou Oaks facility. (3.34B)

Sound

- Amplified sound should not be played on townhouse porches. (3.34M)
- Amplified sound played indoors of townhouses should be kept at a manageable level, so that it cannot be heard when townhouse doors are closed. (3.34M)
- Conversation on porches must be kept at a manageable level, so that residents in other Bayou Oaks facilities are not affected. (3.34M)

Other

- Doors should be closed, should be free of door stops, door props, or items restricting the door from latching. (3.3, 3.14, 3.19)
- Banners, flags, signs, etc. may not be posted, displayed, or hung from townhouses where it covers
 exterior portions of any Bayou Oaks facility, including but not limited to outdoor lighting, windows, doors,
 or entry ways. (3.34C, 3.34N)
- Trash is to be disposed of properly and cannot be tossed or thrown into trash bins. Trash should be placed neatly into trash bins. (3.34F, 3.34S)
