#### 1. Introduction

Meeting was called to order by Nick Tamayo (acting for Christa)

#### 2. Review current fiscal year planned budget and project overview

- FY18 budget was initiated at \$8,000,000
- Remaining balance \$660,315 with 4 projects to approve during this session (pages 6-9)

#### 3. Review notification of approved projects under 50K

- Approved projects were reviewed and are listed on page 4 of the attached presentation
- Campus 800, Landscaping efforts for several locations throughout campus (page 5) TPC of \$19,748.
- Campus 800, ADA pedestrian walkway improvements, this phase is inclusive
  of design services to correct two non-compliant pathways between Wheeler
  and University Drive (page 5).

#### 4. Review action items for campus requests over 50K

- Fleming 564, Air Handler Unit replacement #G22 and #G31 equipment has reached end of service life (page 6), TPC = \$250k Approved
- Hilton 590, S114 Quantity Food and Kitchen Renovation (page 7), TPC = \$1.45m with \$500k being provided by MPEC – Approved
- FC 531, GAR 532, MEL 533, Electrical Transformer Replacement cost was determined to be split Auxiliary and E&G due to space and utility usage. Team was asked to verify if the new equipment will support the new Melcher

- project. Once the capacity is determined, the committee will vote electronically (page 8). Request = \$450k. **Resubmit**
- WT 507, Wortham Theater Roof Replacement and Envelope Design Services. Building has multiple issues that are affecting daily operations (page 9). Phase 1 = \$56k, construction cost have not been determined. – Approved

#### 5. Review of FLS Projects

- HSC 593, Fire Alarm repairs are needed and funding has been approved
- **CHP 517**, State Fire Marshal's Office (SFMO) Means of Egress violation construction funding has been approved (page 10).

# **APPROVED PROJECTS UNDER \$50K**

### Campus 800, Landscaping

- Scope Landscaping hedge installation Lots 16B, 16D, 17A, 19A, 1E, 1B and 19B
- Problem/Issues significant number of damaged and/or missing plants.
- Team: Grounds Department

• **TPC:** \$19,748

ECD: 3Q 2018

#### Campus 800, ADA Pedestrian Walkway improvements

- Scope The UH Veteran Services department has cited two routes at the Main Campus where wheelchair-bound pedestrians experience safety issues related to accessibility between sidewalk and street transitions: one is 1) the path along Moody Towers Residential Hall and the Hilton Hotel leading up to University Drive and the other path is 2) the driveway between Cougar Village and Quadrangle leading up to the Student Service Centers 1 & 2. Currently, there is no striped or delineated paving along route #2 for wheelchairs to safely navigate between sidewalks and vehicle driving/parking lanes. Route #1 currently does not have any clear wheelchair clearance along the entire route to safely cross the street.
- **Team:** Courtney Harper and Associates
- TPC: \$26,000 (Design Services)
- **ECD**: 3Q 2018

## PROJECTS OVER \$50k FOR COMMITTEE APPROVAL

#### Fleming 564, Air Handler Unit (AHU) #G22 and #G31 Replacement

- Issue: HVAC equipment is original to the building and have reached end of life. The subject area comfort levels are increasingly difficult to maintain due to inconsistent performance.
- **Team:** Engineering consultant and mechanical contractor
- **Scope:** Replace two AHU units along with piping, valves, ductwork and connect to building automated system (BAS). The project areas will be tested, adjusted and balanced per UH guidelines.
- TPC: \$250,000
- Schedule: 4Q2018 1Q2019
- **Note:** Use \$189,510 from the FY16 MPEC HVAC funds, remaining funds will come from the FY18 funds (\$60,490).

## PROJECTS OVER \$50k FOR COMMITTEE APPROVAL

#### Hilton 590, S114 Quantity Food and Kitchen Renovation

- **Issue:** S114 is still a relevant resource, it is dated, tired, absent of state-of-the-art technology, appropriate efficiencies in providing faculty-student site lines for instruction and not representative of today's industry standards.
- Team: Brave Architecture and General Contractor
- **Scope:** Replacement of kitchen equipment, Ansil/fire system, hood ventilation and fire suppression. Also to include new wall, flooring, ceiling finishes to modernize the space. Mechanical, electrical and plumbing will be brought up to code. AV components will be introduced to the classroom for
- **TPC:** \$1.45m with \$950k donor funds
- MPEC Funding: \$500,000 (FY18 Classroom Allocation)
- Schedule: 4Q2018 1Q2019
- Note: The project has been vetted through the Office of the Provost.

## PROJECTS OVER \$50k FOR COMMITTEE APPROVAL

#### FC 531, GAR 532, MEL 533, Electrical Transformer Replacement

- **Issue:** During the Fertitta Center Renovation it was determined that the transformers needed to be replaced. The current electrical load is shared between E&G space and athletics. Administration approved the use of HEAF funds at 50% of the cost. The remaining 50% will be paid by the project.
- Team: PGAL and Turner (CM@R)
- Scope: Replacement of the existing transformer and associated materials.
- TPC: \$450k (FY16 Electrical Allocation)
- Schedule: 4Q2018 1Q2019
- Note: The project has been vetted through A&F

## PROJECTS OVER \$50k FOR COMMITTEE APPROVAL

#### Wortham Theater 507, Roof Design

- **Issue:** A roof assessment was conducted late last year, several areas of new and previously reported water infiltration were exacerbated after the hurricane event and the building continues to be impacted during minor rain events. Facilities/Construction Management recommends going forward with design services for the roof replacement.
- Team: WJE (Envelope Consultant) and contractor
- **Scope:** Design Services for the roof replacement and envelope repairs. Cost of roof replacement is not known at this time.
- TPC: \$56k (FY16 Building Envelope)
- Schedule: 4Q2018 2Q2019
