## GRADUATE COLLEGE OF SOCIAL WORK FUNDED RESEARCH COURSE REALLOCATION OF EFFORT POLICY

The University of Houston, a Carnegie-designated Tier-One Research University, values the importance of securing grant funding to support programs of research. As the Graduate College of Social Work implements our strategic plan, we will continue to make concerted efforts to strengthen our research infrastructure and develop policies and procedures that are responsive to faculty needs, as the budget allows.

## I. Course Reallocation of Effort Policy

To reallocate your effort from teaching to research, the researcher must do the following:

- 1. Budget 10% effort (cap of \$10,000) plus fringe, per course, during the 9-month academic year.
- Complete the Funded Research Course Reallocation Request Form once the grant has been awarded.
  - a. The form requires justification for the course reallocation.
  - b. The form also requires a signature from the Associate Dean for Research and Strategic Partnerships confirming that the faculty researcher has the funds to reallocate, and from the Associate Dean for Academic Affairs approving the reallocation.

All course reallocations must be cleared in advance with the Associate Dean for Academic Affairs to ensure appropriate coverage of all courses. This requires notification by October 15<sup>th</sup> for spring reallocations, February 15<sup>th</sup> for summer reallocations, and April 15<sup>th</sup> for fall reallocations. These deadlines must be strictly adhered to in order to ensure appropriate coverage of courses.

Note: Regardless of research reallocations, all tenured and tenure-track faculty are expected to teach at least one class per academic year.
