# Are proposed reform efforts enough to make the criminal justice system more just?



#### NATALIA CORNELIO

## Criminal Justice Reform Program Director | Texas Civil Rights Project

Natalia Cornelio is the Director of Criminal Justice Reform at the Texas Civil Rights Project. Since joining the project, Natalia has settled TCRP's debtor's prison lawsuit against the City of El Paso, has expanded the project's investigations against the Texas Department of Criminal Justice and its unlawful and, at times, unconscionable treatment of its prisoners, and has begun a program to grow police accountability across the state of Texas. Natalia has also worked with local partners to improve conditions for and

decrease criminalization of juveniles who interface with the criminal justice system, and has advocated for parents and children in the immigration system along the United States-Mexico border to be reunified after being forcibly separated from one another by the U.S. government in 2018.

Prior to joining TCRP, Natalia defended the constitutional rights of those impacted by the criminal justice system as an attorney in Houston, Texas for the Federal Public Defender for the Southern District of Texas, and also previously worked on criminal and immigration appeals at the United States Ninth Circuit Court of Appeals in San Francisco, California.

Natalia is a Chicago native who graduated from the University of Chicago Law School. She is currently licensed to practice law in the State of Illinois, and in Federal Court for the Southern and Western Districts of Texas.



#### **JAY JENKINS**

Jay Jenkins graduated from Wake Forest University in 2005, earning a B.A. in Biology and Classical Languages. He received his J.D. from Northwestern University School of Law, graduating magna cum laude in 2009.
