III Administration Representatives Reports: Agnes DeFranco

Academic Standing: When it runs the process will insert a suspension row but it will <u>not</u> cancel future enrollments. Colleges and Departments will have to do that manually.

Grading calendar is available and has been sent to faculty. Students will be able to see their grades on May 14th. Academic Standing will be run 2 days after that date which will require any grade changes to be done on the paper forms, not online.

Grade Rosters will be available on April 25th.

Members noted that WebCT must stay up until after grades are posted.

V Election of UC Chair for 2008-2009

Call for nominations from the floor: none received.

VI University Studies Division Task Force: Preliminary Report: Dan Wells (UC 9756 08S)

Students that matriculate as undeclared have poorer retention rates, poorer graduation rates, and take longer to earn their degree.

Members would like to see actual numbers in the charts, not just percentages of students.

A follow up report will be made to Council in August or September.

VII UC 9749 08S: General Education Assessment: Libby Barlow, Institutional Effectiveness

Report to the State regarding Core includes assessment. A midterm report in 2004 showed that we were largely compliant. The 2009 report will include evidence of outcomes of Core competencies.

Quantative Reasoning Assessment: The review looked at the test bank and homework assignments. There were 500+ students in the sample.

Critical Thinking Assessment: The Rubric will be distributed to faculty for feedback and then a fuller scale assessment will be done. Faculty are encouraged to use this Rubric.

SACS Accountability: one of the compliance issues is general education assessment. UH did not "buy a test" to address this. A compliance plan will document the "what", "how", and results.
