- **III** Administration Representatives Reports:

A The Provost announced at today's Faculty Senate that SACS has approved our reaffirmation of accreditation through 2018, with no conditions. Thank you to all the faculty for their assistance in this process.

SACS also praised our QEP for it's thoroughness.

B The State mandates that all degree programs must observe the 120-SCH limit "unless the institution determines that there is a compelling academic reason for requiring completion of additional semester credit hours for the degree."

Architecture, Engineering, and Education with teacher preparation, all meet the "compelling academic reason" for their additional hours.

UC can expect to see proposals from other department as they revise their programs to meet the mandated 120 hour degree total.

C Dr. DeFranco serves on the Undergraduate Educational Advising Committee at THECB. Current topics they are looking at:

Transfer of 66 hours from a community college. Result when they get to the four year institution is that they often only have to take 54 hours to receive the degree.

Dual credit is that college credit that student receives while in High School. They can, and often do, take many hours which do will not count toward their degree when they select a major in college. The other issue is that they do count toward the enrollment cap.

If you have suggestions on how to address either of these issues, please share them with Dr. DeFranco.

D THECB will begin looking closely at Core Curriculum in 2009. They will be looking at course level (1000- and 2000-levels) and prerequisites.
